## LICENSE

Font licensing can be confusing. This universal license aims to make it as simple as possible: you can use the fonts for almost everything. The only metric you need to think about is the size of the company or studio that is handling the font files. No counting page views, impressions, followers, CPUs, etc.

Example 1. A designer works on a book for a client and only delivers the final product: the designer needs a license that covers the size of their studio.

Example 2. A designer develops a website for a client: the designer needs a license that covers the size of their studio and the client needs a license that covers the size of their company.

Example 3. A designer designs something for a client and transfers the font files to the client: the designer needs a license that covers the size of their studio and the client needs a license that covers the size of their company.

As long as you have purchased a license that covers the number of people working for you, you are granted a perpetual, worldwide, nonexclusive, nontransferable license to use the fonts. If the number of people working for you increases, you have to purchase a license upgrade. The fonts, including all intellectual property embodied in them, are owned by Daria.

## TRIAL FONTS

You can only use free trial fonts to decide whether to buy a license or to pitch design directions to your clients.

## NON-COMMERCIAL LICENSE

This more affordable license is for one person to use for personal use, like portfolios, self-initiated projects, etc.

## STUDENTS

If you're a student, you can use free trial fonts for your student projects and for your portfolio. If you want to use them for commercial projects, you'll need to buy a license.

## SUPPORTING UNDERREPRESENTED FIELDS OF DESIGN

If you are designing a gravestone or anything related to death (mourning cards, funeral invitations, an identity for a death museum or funeral house, publications about death, etc.) you don't have to pay for a license. The only compensation Daria expects is a picture of the complete design. If you really want to give someone money, please donate to a cemetery of your choosing.

## DESKTOP/PRINT RIGHTS

You can install the fonts on all of your devices and use them to make printed and digital documents, objects, merchandise, signage, videos, and similar things. You can use Illustrator and other design software to convert text to outlines and modify the letters for creating logos.

## WEB RIGHTS

You can use the fonts on your website with @font-face. There is no limit on the amount of web traffic. You are only allowed to use the WOFF or WOFF2 files that were sent to you, not the OTF files.

## APP RIGHTS

You can embed the fonts into your app, which can be a game, desktop app, mobile app, web app, etc. Regional variants and versions for different platforms (like iOS and Android) are included. You can't embed the fonts into operating systems, electronic devices, or software that allows end users to create visual materials with them.

## RESTRICTIONS

You cannot assign this agreement or any of your rights under it to any third party. You are not allowed to distribute the fonts, to modify, convert, reverse engineer, or decompile them, to create derivative works or new fonts based on them, to embed the fonts in a way that end users can access them, to store the fonts on public servers, or to put them in public repositories. If you want to do something that is not covered by these terms and conditions or if you have any questions or just need someone to talk to, please contact Daria.

## WARRANTIES, REPRESENTATIONS & INDEMNIFICATION

The fonts are provided on an "as-is" basis,

without any express or implied warranties or representations like warranties of fitness for a particular purpose, merchantability, performance, non-infringement, etc. You warrant and represent that you have the right to enter into this contract and that your use of the fonts will not harm anyone, violate any law, or infringe on anyone's rights. You will indemnify, defend and hold Daria and Daria's subsidiaries, affiliates, parents, partners and licensees harmless from and against any loss, cost, liability, damage or expense (including reasonable attorney's fees and expenses) that Daria or such parties may incur or be liable for arising out of any breach of your obligations, representations, or warranties in this agreement. Daria will not be liable for any indirect, incidental, special, consequential, exemplary or punitive damages arising out of this agreement. Daria's maximum liability will never be more than a refund of the fees received from you under this agreement. Daria produces fonts using modern technology and tests them thoroughly, but can't promise they'll work perfectly with old systems, proprietary systems, or cutting edge technologies. If you need the fonts modified to work in an environment that requires special or unusual engineering, an additional fee might be needed.

## LEGALESE DARIA'S LAWYER TOLD HER TO INCLUDE

This contract contains the entire agreement between the parties and overrides any prior agreements or discussions. It can only be modified or amended by a written document signed by both parties. It cannot be modified or amended by the terms of a purchase order. If something

in this contract turns out to be unenforceable, the rest remains and the unenforceable part will be replaced by the closest possible thing that is enforceable. If Daria waives a right or allows something once, that doesn't mean she has to do it again. This contract is governed by German law with exclusive jurisdiction in Berlin, Germany. Any legal proceedings or disputes will take place in Berlin. The United Nations Convention on Contracts for the International Sale of Goods does not apply to this contract. Nor do any conflict of law principles.
